The Council may depute team of visiting experts to evaluate the facilities and final examination etc. (Theory/Practical) at any time. The final examination shall be conducted in accordance with the norms as prescribed by the Council from time to
- Approval fee of Rs.22,500/- may be remitted to the Council through Demand Draft in favour of 4. Rehabilitation Council of India payable at New Delhi, within one month.
- The shortcoming(s) as mentioned at Annexure-"A" on the reverse page of this order must 5. be removed within 03 months with intimation to the Council failing which the approval shall stand cancelled.
- No admissions shall be taken to the course without a valid prior approval of RCI. In case of violation, RCI will not issue CRR number to the pass outs and the certificate of approval for future may not be considered.
