- The Institute is advised to fulfill all the conditions as prescribed by the Council. The faculty, special school, infrastructure, laboratory, library, curriculum transaction, research & development, etc. should be ensured as per RCI norms throughout the programme. The Council may depute team of visiting experts to evaluate the facilities and final examination etc. (Theory/Practical) at any time. The final examination shall be conducted in accordance with the norms as prescribed by the Council from time to time.
- Approval fee of **Rs.22,500/-** may be remitted to the Council through Demand Draft in favour of **Rehabilitation Council of India** payable at New Delhi, within one month.
- The shortcoming(s) as mentioned at Annexure-"A" on the reverse page of this order must be removed within 03 months with intimation to the Council failing which the approval shall stand cancelled.**
- No admissions shall be taken to the course without a valid prior approval of RCI. In case of violation, RCI will not issue CRR number to the pass outs and the certificate of approval for future may not be considered.


